## Registered Disability Savings Plan (RDSP) Bulletin

An RDSP is a long-term savings vehicle intended to help parents and others save for the long-term financial security of a person with a severe disability.

As you may know it became available to Canadians across the country as of December 2008 and Canada is the first country to offer such a unique savings plan..

While not comprehensive in its scope and has garnered its fair share of criticism, the RDSP program still offers benefits particularly for families with children and young adults with disabilities.

### Highlights:

RDSP is only a "small piece in a much larger puzzle", it is intended to be used as one tool of financial long-term savings. Money put into your RDSP will be sheltered so individuals receiving social assistance can save without their payments being affected. Please check with your social worker or income assistance coordinator for details on provincial guidelines. Being on a low fixed income may not exclude you from enjoying long-term savings benefits. BMO, CIBC and RBC are now accepting applications until December 31<sup>st</sup>, 2009.

Reminder : membership fees are due April 1st. Enclosed is a renewal/application form.

### Challenges:

- To qualify, you must be enrolled in the Disability Tax Credit (DTC) program. You can visit the CRA web site; [www.craarc.gc.ca/disability](http://www.craarc.gc.ca/disability) or call 1-800-959-8281 (TTY users call 1-800-665-0354)

- A person 50 years and older will be unable to receive the matching government grant or bond. For individuals who are finding employment in their 30-40's means less time to contribute to their RDSP

In summary this is a valuable long-term savings opportunity for person's with disabilities. It merits your investigation in spite of it's shortcomings. As with other disability organizations the MLDP will be paying close attention to the upcoming 3 year review to provide constructive feedback, help stream-line the program and also help by raising awareness among potential RSDP beneficiaries.
